## Membership Type

- Makua Membership \$25 (Single, 1 Adult, 18 years or older).** A single member entitled to vote at all meetings of the membership; to be nominated for, be elected to and hold office; to serve on committees to which he/she are appointed or volunteer to be on; and to participate in all of the organization's activities.
- 'Ohana Membership \$45 (2 Adults, 4 Children under 18 years old).** A Family membership consists of 2 Adults and 4 children under the age of 18 years old. Only the over 18 adults are entitled to vote at all meetings of the membership and receive all noted elements of the Makua type membership. Each additional keiki past 4 is \$15.00.
- Kupuna Membership \$15 (60 years or older).** A kupuna member is entitled to vote at all meetings of the membership and receive all noted elements of the Makua type membership.
- Haumāna Membership \$20.00 (Full Time Higher Education Student 18 years or older).** A student at a recognized school or college entitled to vote at all meetings of the membership and receive all noted elements of the Makua type membership.
- Charter Membership \$0.00 (Only for Original Members from the 1989 Club Chartering).** A charter member shall be entitled to vote at all meetings of the membership and receive all noted elements of the Makua type membership. This membership is extended only to Original Charter Members of LVHCC which occurred in 1989.

## Business Membership

- Corporate Partners \$50 (restrictions apply, ask for details).** A registered business, non-profit, social and/or civic type club. Corporate Partners do not vote regarding LVHCC Business. A corporate membership is only for the organization/company. Corporate Members are not counted towards any Per Capita assessments. Corporate Partners provide Business, Non-Profit, or Organization Logos. Your Logo will be placed on the LVHCC Website, Quarterly Newsletter, and Social Media Platforms such as Facebook, Instagram and Twitter. Corporate Partners will have a business listing linked to their logo on the LVHCC website to allow visitors to click on the logo for a brief summary of services offered and contact information.
- Associate Partners \$0 (restrictions apply, ask for details).** An Associate Partner is an organization that relates to and is associated with the LVHCC Program Initiatives, such as Education, Health, and/or Literacy. Associate Partners may not vote regarding LVHCC business. Associates are not counted towards any Per Capita assessments. Provide your business or company Logo. - Friends of LVHCC \$0 (restrictions apply, ask for details).** Formerly known as Community Partners, the Friends of LVHCC option is for organizations and business that relate and associate with the LVHCC Program Initiatives (see Associate Partners above).
